Commercial Fishery Landings of Yellowedge Grouper, Golden Tilefish, and Blueline Tilefish for the Gulf of Mexico

The commercial fisheries landings for the Gulf of Mexico (and S. Atlantic) regions are compiled using the accumulated landings system (ALS), maintained by the Southeast Fisheries Science Center since 1962. Depending on the species however, the landings data records do often not reach as far back as 1962, and reliable commercial landings for a given, identified species, not unclassified landings of the species group, may not begin until the 1980's or even early 1990's. A good example are the grouper species where or classification or identification was not mandated before 1986, the exceptions are the Goliath and Warsaw grouper, which were classified landings data records go as far back 1962.

Total commercial fishery landings from the Gulf of Mexico by the three species of interest for SEDAR 22, Yellowedge Grouper, Golden tilefish and Blueline tilefish, are shown in table 1 and corresponding figure 1.

Commercial landings of Yellowedge Grouper by gear are shown in table 2 and figure 2. Note that the vertical line landings from 1985-1988 average about 340,000 lbs or 34% of the total landings, and are considerably higher than in the period following, i.e. 1983-1993 when they average about 120,00 lbs and only 15% of the landings. The average vertical line landings for remainder of the landings record from 1994-2009 are about 49,000 lbs and 6% of the total.

Commercial landings of Golden Tilefish by gear are shown in table 3 and figure 3. Note that the vertical line landings in 1981 are about 247,000 lbs or 76% of the total landings, and are considerably higher than in the period following, i.e. 1982-1991 when they average about 97,000 lbs and only 21% of the landings. The average vertical line landings for remainder of the landings record from 1992-2009 are about 49,000 lbs and 2.7% of the total.

Commercial landings of Blueline Tilefish by gear are shown in table 4 and figure 4. Note that the percentage of vertical line landings from 1992 to 2009 is fairly consistent and averages around 15% of the total landings.

Commercial landings of all Deepwater-Grouper Complex species in the ALS database for the Gulf of Mexico states from 1986-2009, including the second-tier capture species of Snowy Grouper, Warsaw grouper, Misty Grouper, Speckled Hind, and Queen Snapper, are shown in Figure 5. Commercial landings of the above mentioned secondary species, except the Misty Grouper by gear for each species are shown in Figures 6-9. Average landings of Misty Grouper were about 1,300 lbs from 1992 to 2009 and the average of the last five years was about 1,200 lbs.
