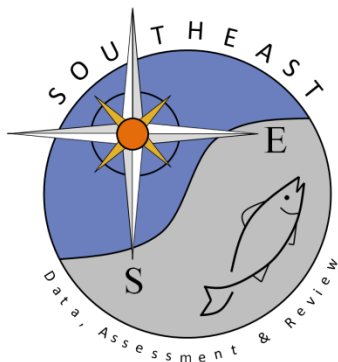

SUMMARY

I assembled a total of 153 pictures from my family collection of historical deep sea fishing pictures to be viewed during the SEDAR 38 process. Included are 146 pictures taken in the Greater Daytona Beach fish camps from the 1940's through 1984 with at least one or more King mackerel seen landed by one of eleven different fishing vessels.

Photographs of seven of the eleven vessels are provided for visual reference. One vessel name from 1984 is not known. Some of the older vessels (1940's to 1960's) normally trolled either all day, or on the way out to and in from known bottom fishing grounds offshore of Ponce de Leon Inlet. From the 1960's to the 1970's some of the bigger fishing vessels only bottom fished, but would catch King mackerels with drift lines, and/or after one would have been hooked up on a bottom fishing rig.

1. Fishing vessel (F/v) Broadbill a party boat (Headboat) was owned and operated by Captain Bob Stone [my uncle] from 1967 to 1974 [16 pictures]
2. F/v Cochise was a smaller boat during the 1950's (No picture of vessel) [1 picture]
3. F/v Flamingo was a party boat owned and operated by Captain Jake Stone [my maternal grandfather] used only for bottom fishing from 1968 to 1975 [26 pictures]
4. F/v Ginger was a fishing yacht owned by George Schultze, and operated by Captain Frank Timmons [my cousin] during 1955 [3 pictures]
5. F/v Kay Jay was a small trolling and bottom fishing boat owned and operated by Captain Jake Stone from 1949-1950 (No picture of vessel) [6 pictures]
6. F/v Little Dolphin was owned and operated by Captain George Locke Jr. during the 1970's (No picture of vessel) [1 picture]
7. F/v Mako was owned and operated by Captain Jake Stone from 1951 to 1968 [82 pictures]
8. F/v Miss Juanita was owned by Captain Redwood Wharton used as a bottom fishing vessel from 1956 to 1966 and operated by Captain Frank Timmons from 1956 to 1960, followed by Captain Bob Stone from 1960 to 1966 [6 pictures]
9. F/v Phyllis K [vessel named after my mother who worked as first mate] was owned and operated by Captain Jake Stone from 1943-1950 [7 pictures]
10. F/v Snow White II was a bottom fishing vessel operated by Captain Bob Stone from 1959-1960 [4 pictures]
11. Unknown trolling/bottom fishing boat from Critter Fleet during 1984 by Captain Paul Nelson III (No picture of vessel) [1 picture]
