### Assessment History

#### SEDAR 3 (2003)

- Unit stock: South Atlantic and Gulf of Mexico as a single unit
- Integrated and Statistical Catch-at-Age models applied to data from 1981 2001
- Combined Sex Models, Ages 0 15+
- Constant natural mortality (0.20)
- Spawning offset: July 15
- 3 Fleets, 3 Fishery Dependent Indices, 1 Fishery Independent index
- Release mortality: 30%
  - The population was not overfished or experiencing overfishing. The population was estimated at nearly two times the size that would produce the maximum sustainable yield.



### Assessment History

#### SEDAR 27A (2012)

- Unit stock: South Atlantic and Gulf of Mexico as a single unit
- Statistical catch-at-age model (ASAP2) applied to data from 1981 through 2010
- Combined Sex Model, Ages 1 12+
- Age-specific natural mortality based on maximum age of 23
- Spawning offset: July 1
- 3 Fleets, 3 Fishery Dependent Indices, 1 Fishery Independent index
- Release mortality: 10% for Recreational, 11.5% for Commercial
  - The population was not overfished or experiencing overfishing. The population was estimated at three times the size that would produce the maximum sustainable yield.
