A Management History database is being compiled, cataloged, and standardized by the Cooperative Institute for Marine and Atmospheric Studies (CIMAS) of the University of Miami in collaboration with the Rosenstiel School of Marine and Atmospheric Science (RSMAS), the National Oceanic and Atmospheric Administration (NOAA), the National Marine Fisheries Service (NMFS), and the Southeast Fisheries Science Center (SEFSC) Fisheries Statistics and Sustainable Fisheries Divisions.

The Management History Database effort involves:

- Identifying Federal Register documentation associated with management actions affecting federally managed species throughout the Gulf of Mexico, South Atlantic, and U.S. Caribbean regions.
- Creating standardized records specifying the Fishery Management Plan (FMP), species, jurisdiction, and fishing sector (commercial and recreational) to which each management action applied.

Once complete, the goal of the database is to provide a comprehensive and standardized record of published management actions to increase the efficiency of fisheries stock assessments, ACL monitoring, and ecosystem approaches. However, the database is still in development and is not yet available to the public. The intention of this working paper is not to replace current management history documents, but provide complementary tables of cited regulations.

For the SEDAR 74 research track assessment we queried a prototype of the database for records related to red snapper in the Gulf of Mexico. The records associated with bag limits, size limits, and closures were reviewed and are summarized here. Table 1 - Table 4 outline bag limit and size limit records for red snapper from the Reef Fish Resources of the Gulf of Mexico Fishery Management Plan as they are currently documented within the Management History database.

Table 5 - Table 8 outline closures and reopenings for the recreational and commercial fisheries. Recurring regulations include seasonal, monthly, and weekly closures and reopenings that reoccur periodically over the time periods specified in Tables 5 and 7. In addition to these recurring rules, distinct closures and reopenings are documented that may overwrite or exist simultaneously with the recurring regulations. Distinct closures are outlined in Tables 6 and 8. For this working paper, we have separated these records into individual tables as the database is still in development.
